# Morning Screening Process- Greeley

For students who do not have proof of vaccination uploaded to Operoo, parents/guardians will be required to continue completing the Operoo daily health screener

Students Will NOT be required to show proof of vaccination or Operoo completion in the morning (our staff will verify the unvaccinated students have completed the screener in the morning)

All students will still be required to complete a temperature check upon arrival



The non-school day screening process for athletics will remain the same for all students

# “Test to Stay” In School



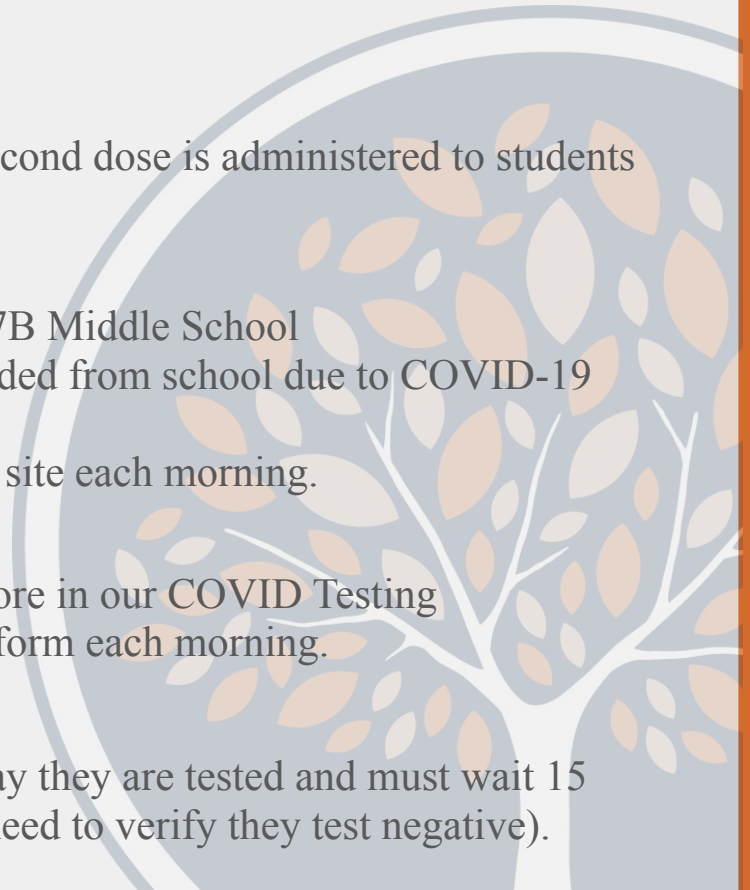
# Test to Stay = Procedural Requirements

- Students must be tested by CCSD before school (or privately the morning before school) for five consecutive school days.
- Students are not permitted to enter CCSD buildings until after a negative result is secured.
- Home tests are not permitted.
- Students are still required by the WCDOH to quarantine outside of the school day.



# Test to Stay - Structure

- Duration November 29, 2021- February 1, 2022
  - Test to Stay will run two weeks “after” the second dose is administered to students onsite by WCDOH
- Testing will take place from 8:05 am to 8:30 am - 7B Middle School
  - Testing is for any unvaccinated student excluded from school due to COVID-19 exposure (this includes home exposure).
  - An adult must drive the student to the testing site each morning.
- Families will need to sign up by 5pm the night before in our COVID Testing Management System and submit a signed consent form each morning.
- Students will be required to attend school on the day they are tested and must wait 15 minutes before entering our school buildings (we need to verify they test negative).

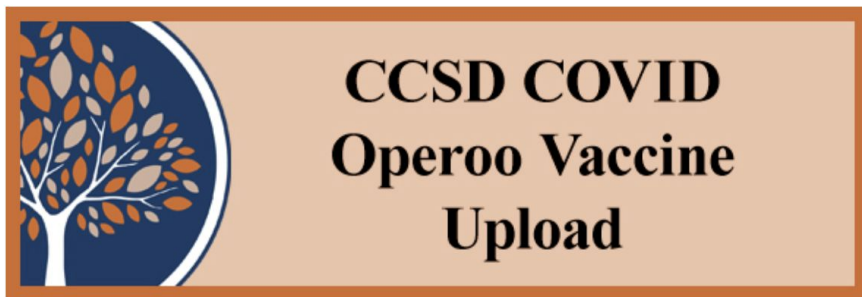

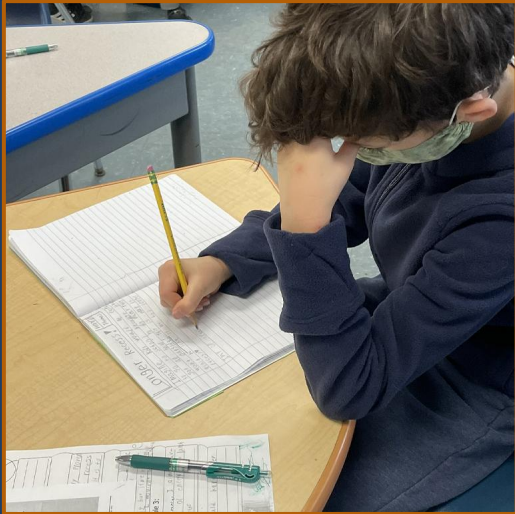
